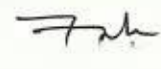

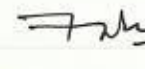

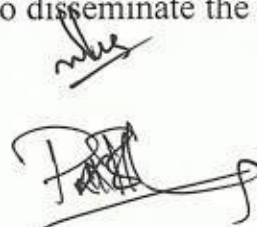
- 1 This Trust will be called as "R S EDUCATIONAL AND CHARITABLE TRUST"

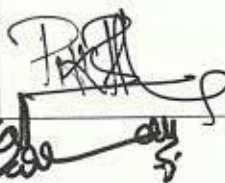
(b) To promote and bring awareness about Human rights and to fight against injustice to the people of all class and to disseminate the government policies in this regard among the public.

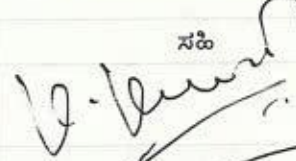

- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, color, race, creed or sex.
- (d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.
- (e) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharmshala and rest houses, for use by public in general.
- (f) To establish, maintain or grant aid to homes for the aged, Orphanage & or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- (g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food clothing or other help.

8 TRUSTEES TO RENDER TRUE ACCOUNT:

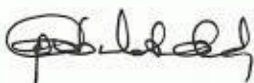
The trustee shall cause true and accurate account to be kept of all money/s, received, and spent and all materials in respect thereof during management of trust fund or in relation to carrying out the objects and purposes of the trust as well as asses, credits and efforts of the trust.

9 POWERS OF THE TRUSTEES:

For the furtherance of the objects, i.e., for service to the community in general and to the poor and weaker sections of the Trust as mentioned in clause 5, the Trustees will have the following powers which will be exercised by them.

- To accept any donations, contributions, grant or subscriptions in cash or in kind from any person, body of persons or Trust.
- To apply the whole or part of the income of the trust or accumulation thereof in whole or part of the corpus of the trust fund for any one or more of the objects of the trust as the trustees may, in their discretion from time to time, determine.
- To convert and deal with investments comprised in the trust fund and/or to carry the investment for the time being in the modes prescribed u/s, 11 (5) of the I.T. Act 1961.
- To invest and keep invested the trust fund either in the purchase or mortgage immovable property including a flat or in units, shares, stocks or debentures permitted by the Indian Trust Act, 1882 or any other statute, or deposit with banks, firms and to alter, vary or transpose such investments from time to time as the trustees may in their discretion think fit for others of the same or different nature.
- To borrow or raise or secure payment of money and also lend money either with or without security at the discretion of the trustees.
- To sell, dispose of alienate or otherwise deal with property belonging to the trust including property comprising the trust fund.
- To borrow money on behalf of the trust and charge the assets of the trust in respect of such liability incurred on behalf of the trust.
- To charge, convert or sell any of the trust's property, investments or assets including immovable / moveable property.
- To let out premises and immovable property of the trust for such period and at such rent and on such terms and conditions as the trustees in their discretion may think fit.

- j. To open accounts with any nationalised banks, Co-operative banks and other financial institute operate such accounts and to give instructions to the banks and to provide for the opening and operation of such accounts by the mutual consent of the Trustees
- k. To appoint constitutes attorneys or agents and delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agent and appoint others in his/her or their place.
- l. To make, vary, alter or modify schemes, rules and regulations for carrying out the objects hereof and of having, any trust at any place in furtherance of the objects of the trust and otherwise for giving effect to the objects of the trust.
- m. To set apart or accumulate the whole or part of the income or corpus of the trust fund or part thereof for any subscription or donation made by them.
- n. To join, co-operate or amalgamate this trust with other or others having kindred or allied objects upon such terms and conditions as the trustees may in their discretion think fit particularly having regard to the objects and nature of this trust.
- o. Executive committee shall arrange for the publication in any manner trust's journal, documents as may be considered fit in the furtherance of its objectives and committee shall have powers to fix its price also the rates of advertisements from time to time.
- p. The trustees shall be chargeable only for such money, stocks, shares and funds as shall actually come in to their hands. A trustee shall not be answerable or accountable for neglect, default, acts of commission or omission of the other trustees nor of any bankers or other person with whom the trust properties or any securities comprised in the trust fund have been deposited or kept.
- q. The trustees herein shall stand indemnified against any act done in good faith and without negligence.

10 THE PROPERTY OF TRUST SHALL INCLUDE:

- a. Such contributions, donations, endowments, settlements made by the public, government, institutions etc., for the purpose of advancement of aims and objectives of the Trust.
- b. Such acquisition and accretions to the Estate of the Trust.
- c. A sum of Rs 1001/- (Rupees One Thousand and one Only) donated by the Author.

11 The Properties, the assets, effects funds and other things of the Trust shall vest upon trust in the Trustees perpetually and irrevocably for the due fulfilment and effectuation of the objects and purpose of the "R S EDUCATIONAL AND CHARITABLE TRUST"

12 THE ADDITIONAL AIMS AND OBJECTS OF THE TRUST SHALL BE:

- a. To conduct, promote or patronize through instruction and education of public opinion or to assist in promotion or conduction activities for the betterment of society.'
- b. To spread or assist to spread education including physical and moral training.
- c. To provide or assist in promoting the understanding of history, art, literature, music, dance and other cultural forms of India and conduct or assist in conducting research in these fields, public results thereof.
- d. To establish or run or assist in establishing or running libraries, resource centers, training centers, schools, museums, research institute cultural schools (i.e., music dance drama art etc.) as well as medical centers as well as other relief centers for general public utility.
- e. To permit the use of movable or immovable properties and assets of the Trust without profit motive by institutions whose objects are similar to the objects of the Trust.
- f. To conduct or assist in conducting activities of art music dance, drama, folklore, literature scientific and charitable nature to all or any of the objects of the Trust and for the achievement of the objects mentioned herein.
- g. To acquire by lease, purchase, gift, mortgage, license as beneficiary under any other Trust or otherwise lands, properties, machinery etc., from Government or semi Governmental authorities, trusts and corporations, institutions and societies as well as individuals to sell, alienate, gift lease mortgage manage or in any other legal manner transfer properties belong to the Trust and also to give the same on lease or license for the furtherance of the objects of the Trust.

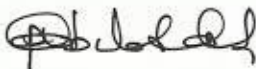

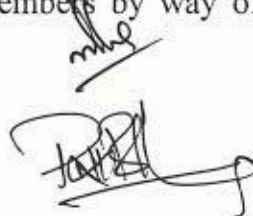

- h. To raise secured or unsecured loan from any schedule Bank or any other financial institutions or Co-operative Banks or firm or individuals or as any other institutions including any registered society or trust with or without interest whenever necessary for furthering of objects of the Trust.
- i. To receive voluntary donations in cash and kind from any individual or associations for the purpose of carrying out the objects of the Trust.
- j. To support and render financial assistance to charitable and educational causes and institutions, organizations (companies) trust, societies or individuals in the form of donations, loans or otherwise on such terms and conditions as the Trustees deem for and proper which in the opinion of the Trustees would help to carry out all or any of the objects of the Trust.
- k. To give scholarships award, stipend, honorarium to such individuals who have devoted themselves and render their valuable service in cultural educational social and various other public causes.
- l. To put up suitable buildings or other constructions, to maintain, alter and equip them suitably with machinery and other things and to the discretion of the Trustees to permit their use on lease or license to institutions or organizations devoted to the objects which are similar to those of the Trust.
- m. To offer monetary assistance by way of donations or otherwise render help to mitigate the hardships caused to the general public on account of floods, famine or other natural calamities.
- n. To do all such things as the Trustees may think proper and necessary for the attainment of the above subjects
- o. The benefit of the Trust shall be open to all people irrespective of caste, creed and religion
- p. The funds and the income of the Trust shall be solely utilized for the achievement of its objectives and no portion of it shall be utilized for the payment to the Trustees/Members by way of Deposit, profit, interest, dividends etc.

1. CANCELLATION OF TRUSTEESHIP:

The Trustee

- i) Who is convicted (Imprisoned) by any Judicial Court in India.
 - ii) Who has become insolvent legally?
 - iii) Who is entangled / indulged in any criminal case also
 - iv) Who is suffering from mental disorder and in case of death of a trustee.
- Such Trustee is liable for ineligibility and his Trusteeship will be cancelled.

2. BOARD OF TRUSTEES:

The Board of Trustees will be having an initial batch of Trustees to the extent of 'Four' only.

3. ANNUAL MEETING:

Annual meetings will be held during the end of April every year.

4. SPECIAL MEETING:

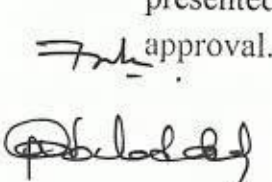
In case of insistence by two third majority of total trustees, the Advisors of the trust shall call for such special meeting.

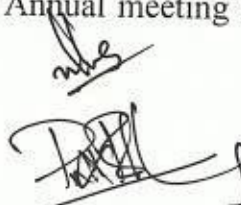
5. QUORAM:

Two thirds majority of the total trustees are required for each meeting. However, in case of inadequate quorum at the time of stipulated meeting, the meeting can be postponed for another half an hour only, and then can be conducted irrespective of quorum, subject to discuss the matters as per AGENDA.

6. ANNUAL REPORTS:

The audited statement of accounts, annual reports and budgets shall be presented at the time of Annual meeting for necessary verification and approval.





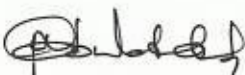
7. DUTIES OF BOARD OF TRUSTEES:

- At least once in a month meeting should be conducted by fixing a suitable date and time.
- Quorum required is as per Para 5 above and the same condition are also applicable here.
- Trust is responsible for all moveable and immovable property.
- In case of cancellation of membership of any Trustee for the reason whatsoever it may be the trust, which can elect or co-opt other suitable person to that place.
- The trust shall verify all applications for trustee and appropriate action.
- The trust is empowered to have the help and co-operation of the State Government, Central Government, other association Organization and public in general through the managing Trustee with the help of other Trustees.
- Action in connection with any matters shall be enforced and after getting approval during the meeting.
- To appoint or make provision for the appointment of any person (including all or any of the trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to appoint or provide for the appointment of separate trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.

8. DUTIES OF THE CHAIRMAN/PRESIDENT:

- The CHAIRMAN/PRESIDENT shall preside over the meeting and see smooth and successful meeting is conducted.
- He shall take active participation for each and every work as a leader and see that every work is done without any obstruction.
- He shall look after the entire letter correspondence of the trust.
- In case of equal majority while casting the vote, irrespective of the matters, the Managing Trustee is empowered to cast his vote for deciding the issue, which is final and binding on all the Trustees.
- All financial transactions pertain to the Trust must be dealt with by the Managing Trustee with the help & co-operation of any other Trustee.

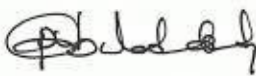

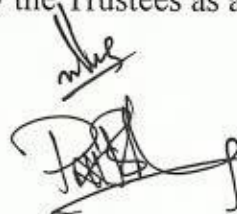
9. AUTHORISATION TO CHAIRMAN/ PRESIDENT:

In the interest of smooth and better functioning of the Trust, the Chairman/ president is hereby authorized to undertake the following.

- a. Shall look after the letters correspondence.
- b. Shall send or arrange to send notices of meetings to all the Trustees in time.
- c. Shall release amount for each program duly maintaining the amount with relevant documents properly.
- d. Shall get the statement of accounts audited every year and obtain the approval during the annual meeting.
- e. Shall prepare annual report and budget and get the approval from the annual meeting.
- f. Is empowered to purchase or legally acquire any land/buildings etc. required for the Trust.
- g. The Managing Trustee shall at their discretion co-opt any person/ or persons who may be helpful in achieving the objects of the Trust as a Trustee.
- h. Empowered to avail any type of help and co-operation from the Government or general public or any other association organization in the interest and welfare of the Trust.
- i. Empowered to represent the Trust in all the fields and can keep any letter/document in his possession.
- j. Empowered to appoint person/persons for the post(s) created so as to attend day-today work of the Trust and also to take action legally against any employee of the trust.
- k. Is totally responsible for each and every matter or correspondence.

11. **ACCOUNTS CLAUSE:**

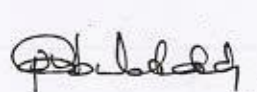
